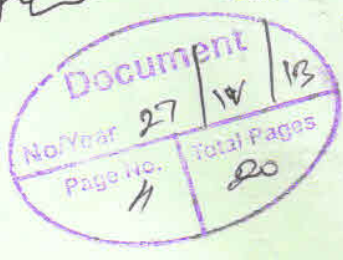

NOW THIS DEED OF TRUST WITNESSETH:

- I. The name of the Trust shall be "MARUDHAMALAYAN EDUCATIONAL AND CHARITABLE TRUST"
- II. The trust shall hold its office at 3/128, H . Karuvalur Road, Manickampalayam, Kunnathurpudur –PO, Coimbatore -641 107 or any other place or places as may be decided by the Trustee from time to time.
- III. THE OBJECTIVES OF THE TRUST ARE:
 1. To start Health units and health education centres in remote and rural areas.
 2. To start, run and administer training institute.
 3. To impart and organize training programme.
 4. To run vocational training centers.

5. To render career guidance services.
6. To extend counseling services to the community.
7. To conduct research studies.
8. To foster research in the field of social Science and other scientific and management field, that plays an important role in the development of the individual and also the community as a whole, which shall also include such other units like family, homogenous groups and to provide for and the production such materials like training materials, videos, ad films etc.,
9. To arrange for discussions, lectures in the field of Social Science and other related field and allied subjects.
10. To publish article, newsletters, journals and such other published materials.
11. To provide consultancy services
12. To collaborate with other research, training and financial Institutions.
13. To implement community development programmes.
14. To establish, maintain and grant aid for educational institutions like Schools, Colleges and Universities, including training institutions, which offers both the formal and informal education, to individuals, groups, NGO' s etc., and also maintain hostel to cater to the students and trainees of the institutions run by the trust.
15. To help the people irrespective of caste, religion and creed to enhance their earnings by giving training in various fields and make them self reliant and also running industries of small scale nature and / or otherwise to generate employment for the benefit of the People.
16. To run hospitals, crèche, day care centre, old age home orphanage, destitute home, home for the mentally retarded blind and other handicapped people, deaddictioncentre and school.
17. To provide shelter for street children and to assist them in all the ways that are necessary for them to get assimilated into the society and to eke out living in more acceptable means of earnings.
18. To provide legal services for needy people.
19. To protect environment from pollution.
20. To raise nursery and herbal plants.
21. To concentrate on gender concerns.
22. To conduct awareness programmes on social issues.
23. To foster research in the field of training and other social sciences, including such other facet of knowledge that can be utilized for improving the society as a whole.

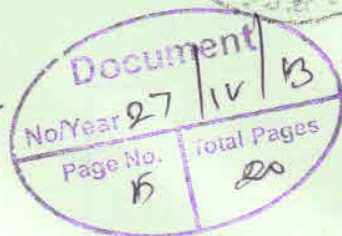

24. To create an awareness among the people about the evils of female infanticide and help to put an end to it and also establish and maintain cradle centre for the under privileged sex.

25. To create an awareness among the people about the Acquired Immune Deficiency Syndrome (AIDS) Leprosy and other infectious diseases and educating them in preventing it and also in eradicating the social taboo's related to it and to rehabilitate those who are affected.

26. To rehabilitate drug addicts and make them self-reliant.

27. To cater to the needs of the people in both basic and advanced health care including mental health, by establishing and maintaining clinics and also mobile clinics to reach the un reached and to conduct special camps such as eye camp etc.

28. To organize women groups to make them understand their rights and duty and to improve their life standard in all spheres by themselves shedding their dependent mentality.

29. To undertake need based scientific studies and result oriented action projects in the area of rural social development and also for the urban people.

30. To initiate, administer and assist programmes for providing better nutrition for children expectant mothers and old age people among the poor in the backward parts of rural areas.

31. To promote adoption of new innovations in agriculture, health, family planning, sanitation etc. among rural poor and farmers.

32. To organize discussion groups for the study and understanding social, economical, political, educational, philosophical and international problems in an academic and non partition spirit and publish the results of such discussion in the form of books pamphlets or journals.

33. To organize relief in times of emergency and on the occasions of general social distress such as floods, famines, epidemics, cyclone, fire and other disasters including man-made, which hinders development.

34. To offer fellowships scholarships and prizes in furtherance of the objects of the Trust.

35. To form Self - Help Groups (SHG's) among women and initiate credit and saving scheme for they're own betterment financially socially and economically.

36. To grant, pay or give scholarship, stipends, prizes rewards, allowance and other financial assistance or help in cash or kind to students with aview to help them in completing their studies in schools, colleges, educational institutions, technical institutions, art school, institutions teaching commercial and other arts including teaching of cultural arts or other training research or educational works in India or abroad.

37. To promote assist and / or maintain all activities by whomsoever carries on or wherever carried on in India in conformity with the objects of the Trust and as are conducive to the well being and general welfare of the nation or are conducive for advancement of any object or objects of general public utility not involving / carrying on any activity for profit.

38. To solicit, receive, hold and disburse funds to promote the objects stated above and to hold funds and investments in trust for the said objectives.

39. To open and operate accounts of any description with any scheduled bank or banks or government approved housing financial institution for the trust.

40. To purchase, take on lease, leave and license or otherwise acquire and to hold, manage, administer and otherwise deal with any movable and immovable properties, right and privileges as the board of Trustees may deem necessary, expedient or desirable for the promotion of any of the objectives of the Trust.

41. To sell, alienate, lease give out on lease, or license mortgage, charge, pledge, hypothecate, transfer surrender dispose of and / or otherwise deal with all or any of the properties, funds and assets.

42. To appoint agents or representatives or other workers on such conditions as may be thought fit by the Board of Trustees.

43. To enter into any contract or agreement or any other transaction for the purpose of promoting any or all the objects of the trust.

44. To carry on such other objects as may be incidental for the promotion of any of the aforesaid objects or any other ancillary objects, related to them as may be considered fit by the Trustees.

IV. THE TRUST MANAGEMENT:

1. There will be a Chairman, one Vice Chairman, one Managing Trustee, one Secretary and maximum 3 Directors forms the Managing Committee of the Trust. Secretary can be appointed from outside the trustees by the board if desire. If the secretary is appointed from outside he / she will not have voting right.

2. All the above positions are for a period of two years. All posts are filled during annual board meeting through democratic procedure of by voting if there are more people contesting for any post.

3. The Secretary will conduct the election procedure, if the Secretary himself is contesting for any position the Board will nominate any one trustee or any other competent person to conduct the election process.

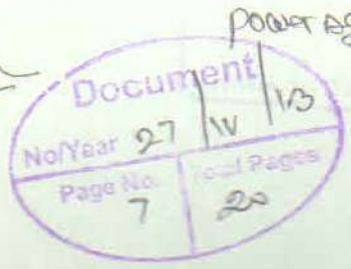

2. The Trustees will act as Trustees for their life time.

3. The Board shall have at the maximum of 20 (TWENTY ONLY) Trustees.

5. The number of the trustees shall not exceed 20 (TWENTY ONLY) at any point of time.

6. In the case of incapacitation, resignation, retirement etc., of a Trustee, he or she has the power to appoint any legal heir in his/ her place as Trustees. In case of death one of the legal heir as per Indian Constitution and law can become Trustee.

7. In case if any of the trustee acts in such a way that may be detrimental to the Trust or in case the majority of the Trustees feel that such Trustee is to be terminated from the Trusteeship, then three fourth of the Trustees shall pass a resolution to that effect there upon he or she is terminated from trusteeship.

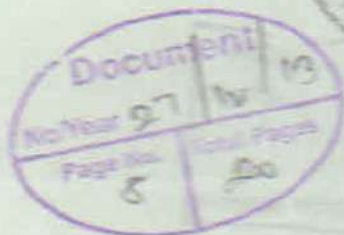
V. MANAGEMENT

VI. BANK ACCOUNT

The Bank account/s will be operated by the Managing Trustee and any one or two of the remaining Trustees, as may be decided by the Board of Trustees.

VII. INVESTMENT OF TRUST FUND

1. The income and the funds of the Trust shall be utilized only towards the objects for which the trust is formed, and it shall be under no circumstances be utilized for payment to the trustees, authors, founders or members of the trust or to any of the person mentioned in sec. 13(1) of the Income Tax Act 1961 by way of profit / dividend / interest etc.

2. The initial corpus of the Trust shall be deposited in any of the Nationalized / Scheduled banks.

3. The Board shall have power to invest the corpus or the Income from the trust, fund, or the receipts received including donations, subscriptions or otherwise, at their discretion as per the provisions of the Income Tax Act 1961 as amended from time to time.

VIII. ACCOUNTS AND AUDIT

The Accounts of the trust shall be annually audited by a qualified chartered Accountant as defined in the Chartered Accountants Act appointed by the Board and the audited statement of accounts shall be placed before the board for its approval within six months, of the close of financial year, that meeting shall be called the annual meeting of the trust, whereas the appointment of auditors for the next year is to be appointed. The elections for Managing Committee, appointment of new trustees in the place of the retiring trustees are to be made during the Annual meeting. The trust shall apply for registration with the income tax commission as a non-profit social and charitable trust and in pursuance of that a return as specified under the income tax act is to be filed with the department every year after the annual meeting.

IX. MEETING OF THE BOARD OF TRUSTEES

- 1. In addition to the annual meeting the Board may meet from time to time.
- 2. The Managing Trustee of the Trust shall call the Meeting and the Managing Trustee shall preside over the meetings.
- 3. The board shall transact any business that may be specified in the agenda or otherwise agreed to, by the Board members.
- 4. The Board shall also appoint an auditor at its annual meeting for the subsequent year.
- 5. Fifty percent members shall constitute quorum.
- 6. The meetings of the Board shall be convened after giving at least a week's notice unless, those who are entitled to receive notice agree to accept a shorter notice.

7. The Managing trustee may invite other persons, who are interested in the work of the Trust to attend the meetings of the Board but they shall not be entitled to vote.

8. The Board of Trustees, to manage the affairs of the trust, more effectively may employ staff etc. and they shall be paid remuneration fixed by the Managing Trustee.

9. In case of voting on any matter results in tie, the Managing Trustee shall have an additional casting vote.

X. AMENDMENTS

1. While this trust shall be irrevocable, the board may amend the clauses relating to membership and management and also pertaining to the objectives of the Trust, which shall include deletion, amendment, addition of objectives of the trust, at the duly convened meeting of the Board by a resolution passed by the three fourth of the Trustees, and for passing such resolution at least two week's notice shall be given to the persons entitled to attend such meeting.

2. If any alteration or amendment to the trust deed becomes necessary the same shall be carried out only with the prior approval as may be prescribed in the Income Tax Act, 1961 as amended from time to time.

3. If any alteration or amendment were necessary the same shall effected through supplementary deed / deeds and it / these shall be read together with this main deed.

XI. GENERAL

1. The operation of the trust shall be carried out within India however this shall not prevent the trust from receiving funds either in cash or kind from foreign sources, within the provisions of Foreign Contribution (Regulation) Act.

2. The benefits of the Trust is open to all irrespective of caste, religion, creed etc.

3. The financial year of the trust shall be from "April 1 to 31st March" of each year.

4. At present there is no movable or immovable assets in the name of the trust, except the capital fund of Rs.1000/-

XII. DISSOLUTION OF THE TRUST

If the trust is to be dissolved the funds, the assets of the trust at the time of dissolution of trust, is to be transferred to a Trust having similar objectives and under no circumstances, it shall be distributed in any form to the authors, founders, trustees or members of the Trust.

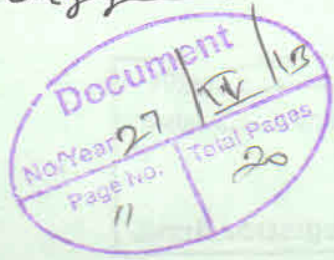
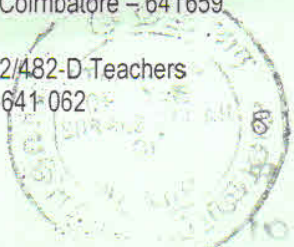

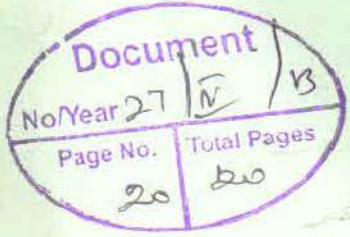
